Please allow me to address certain issues we have been discussing:

1. Lew, when we met earlier this week, you indicated you and your client would provide this office with a list of doctor's appointments for Kyle. Mr. Lagares provided the following information with regard to those appointments: February 27: 2:30 p.m. for occupational therapy at Mercy Physical Therapy in Lebanon, Missouri, and 3:00 p.m. for speech therapy; February 29: 2:00 p.m. and 2:30 p.m. (he was not specific where or with whom the appointments are); March 7: at Mercy Pediatrics in Lebanon, Missouri, with Dr. Hopkins at 3:50 p.m.; every Wednesday with Dr. Beatty at 10:00 a.m. (but no location for Dr. Beatty). 2. We have been advised Nicole is now attending daycare. If Mr. Lagares needs information from the daycare Ms. Lagares will provide it to him. Before we divulge where Nicole is attending daycare, we need assurance from Mr. Lagares that neither he nor any member of his family will go to the daycare and disturb Nicole's day, nor will he pick her up from daycare unless prearranged with Ms. Lagares. The daycare will be made aware of these parameters. Please advise.
3. It is our goal to start some regular weekend visits with the children together. We want to start with Kyle seeing Ms. Lagares first. Please let me know when we can start this and what times the parties are available. We propose every other weekend wherein each parent has both children starting with Ms. Lagares.
